We have reviewed the accompanying Statement of Unaudited Financial Results of **Shiva Suitings Limited** ("the Company") for the quarter ended June 30, 2023 and for the period April 01, 2023 to June 30, 2023 ("the Statement") attached herewith, being submitted by the Company pursuant to the requirement of Regulation 33 of SEBI (Listing Obligations and Disclosure Requirements), Regulations, 2015 ("the Regulation") as amended, read with SEBI Circular No. CIR/CFD/CMD1/44/2019 dated 29th March 2019 ("the Circular").
